educated at Eton College. He entered the Diplomatic Service in 1900 and served Cairo,

Tehran and Petrograd; 2nd. Sec 1906; transferred to Foreign Office 1907; resigned FO

appointment 1911. Managing Director, Baring Bros. & Co. Ltd. 1913-14; various

positions in Royal Household; British Govt. Director of Suez Canal Co. 1926-50. He

married in 1908 Lady Ruby Elliot - 1 son, 2 daughters. He died 13 May 1953.
