Educated Oxford University. Middle Eastern banker, 1890-1950. Joined Ottoman Bank in 1890 and went to Constantinople. The Governor of the Ottoman Bank, Sir Edgar Vincent, was a friend of Arthur Dickson's father. After initial training sent to Philippopolis in Bulgaria and later served in three branches in Asia Minor, starting with a branch in Balukessor. Resigned from the Ottoman Bank in 1897 to take up the post of Financial Controller of the Provisional British Administration of the Candia province of Crete. Left Crete in 1899. Offered job of the Manager of the Ionian Bank Ltd and Inspector of their Greek branches and moved to Athens. In 1904 applied for the vacant post of Sub-Governor of the National Bank of Egypt and stayed in this post until 1917 when he was offered, by Lord Faringdon, the position of Manager of the new British Trade Corporation, which he
