Biographical history: Edwards, Stephen Herbert St George (1912-1997)

Born 10 November 1912 in Long Bredy, Dorset the son of a clergyman, Reginald Dawson Edwards. Attended Normandale Preparatory School, Bexhill-On Sea and St Edwards School, Oxford 1926-1930. Joined Palestine Police 11 April 1936. Served as a Constable in the Foot branch (Force No.383) 25 April 1936, as a constable in mounted branch from 10 Oct 1936, 2<sup>nd</sup> sergeant in mounted branch from 20 Jan 1939, 1<sup>st</sup> sergeant in foot branch from 1 June 1942, A/ASP [Acting Assistant Superintendent of Police] in P.M.F [Police Mobile Force] from 1 Apr 1944 and B/Inspector in Inspectorate from 1 Oct 1945, (employed on recruiting duties in the United Kingdom from 18 June 1945 to 11 October 1945) confirmed as Assistant Superintendent Palestine Police Force from 1 April 1947. Stephen Edwards served in the Palestine Police until 31 March 1948. He then served in the North Borneo Police, 1949-1963. Worked as Commissioner of Road Transport in Sabah (Malaysia) from 1963 until his retirement in 1969. Married 14 July 1945, Isabel Mary Tullis (1913-1990). One daughter Dorothy Frances and one son Andrew Edwards. Died August 1997. For further biographical details see file 1/2 sheet 1 and 2.
