Born in Plymouth on the 25 Apr 1933 and educated a Plymouth College. Worked in family business 1950-1951 and 1953-1956. National Service in the Royal Air Force (Germany) 1951-1953. Served in the Metropolitan Police London 1956-1959 when transferred to the Nyasaland/Malawi police where retired as a Superintendent in 1971 under legislation to further localisation. 1971-1974 two periods as a civilian with the Ministry of Defence and employment as a manager with Spiller French Baking. 1974-1980 a Superintendent-Divisional Commander the New Hebrides Anglo French Condominium (later Vanuatu). Left on completion of contract at Independence. Last year in Northern Division keeping an eye on Jimmy Stevens who had declared Espiritu Santo the Republic of Vemarana and was later arrested and convicted of leading what the Press called "The Bow and Arrow Coconut Rebellion". 1980-1984 Royal Oman Police, Major (Grade 1 Superintendent) general duties including commanding the Airport Division. Left on completion of contract. 1985-1987 Security Manager Sierra Leone Port Authority effectively commanding a small force of some 350 officers and men, all sworn Constables. Left on completion of contract. 1987-1988 Port Security Consultant United Nations Conference on Trade and Development (UNCTAD) Colombo Sri Lanka. 1988 set up and ran as Operations Director Maritime and Aviation Security Service (MASS) part of the Capitol Group, then Chairman of the uniform division of Capitol Group PLC until retirement in 1997. Married with three daughters and a son. Interests include all sports, playing golf and walking the dogs on the moor.
