Biographical history: Stewart, William David (b.1926) Palestine Policeman

William 'Bill' Stewart was born in Bridge of Allan in 1928 and was educated at Hurst Grange Prep School in Stirling, and Fettes College in Edinburgh. Stewart served as a constable in the Palestine Police force from the 22nd of December 1946 until the 11th of May 1948. He was transferred from Safad to Farradiyeh Police Post in March 1947. His work in the force was considered 'exemplary.' Bill married in 1950 and has three daughters. He lived in Bo'ness, Stirling, Dumfries and Henley on Thames. Finishing his working life in Henley on Thames as Europe Production Manager for Stelrad Steel Radiators, he retired back to Bo'ness in 1986 to be near to his daughters and granddaughters. Stewart held membership in the Palestine Police Old Comrades Association intermittently from its conception in 1947. Following a letter in 1988 from the General Secretary of the organization inquiring about re-joining, Stewart went on to hold membership until at least 2007. As part of his membership, Stewart attended events in 1998 and 2005, to commemorate the 50th anniversary of the end of the British Mandate in Palestine and the 25th anniversary of the Scottish branch of the Old Comrades association respectively.

Scope and content: Papers and audio-visual material relating to William Stewart's service in the Palestine Police including a policeman's notebook, a 1947 Christmas dinner menu and his 1949 certificate of discharge. The majority of documents relate to Stewart's membership and involvement with the Palestine Police Old Comrades Association, and material relating to reminiscing about his time in Palestine. These include a constitution pamphlet, certificates of membership and details of dinners in 1998 and 2005. Material relating to reminiscing about his service in Palestine include a list of some colleagues compiled in 1991 and two VHS cassettes of a Palestine Police recruitment film and the BBC documentary 'A Dream so Fair: The Palestine Police.'

	Documents relating to William Stewart's time as a member of the Palestine Police Force. Consisting of a police notebook, a 1947 Christmas dinner menu and Stewart's 1949 certificate of discharge.		
1/1	<u>Police Notebook</u> William Stewart's Palestine Police Force notebook. The front page includes rules of usage of the notebook in English, Hebrew and Arabic. The first entry is on the 6 th Feb 1947 at 5.05pm, with Stewart noting that there was nothing to report. Entries include that of 11 th Feb 1947, which details Stewart's involvement in the escort of a man charged with attempted murder following the discovery of blood stains on the ground. On the 18 th May 1947, Stewart arrived on the scene of the murder of Ahmed Abdulla by shooting. Stewart remained on the scene until reinforcement arrived to remove the victim. Appears Stewart may have used this notebook after his discharge. Entries after the 15 th April 1947 feature British addresses and calculations which may relate to Stewart's later work as a manager of a radiator company.	1947	1 notebook

<p>William Stewart's copy of certificate of discharge from the Palestine Police Force. Details Stewart's 'exemplary' conduct during service and his rank as Constable. The document was signed by the Inspector General on 1st of Oct 1949, and details the exact dates of Stewart's service which were the 22nd Dec 1946 to 11th of May 1948.</p>

The goals of the organisation were to continue the comradeship fostered in Palestine and also to support 'distressed members' by attempting to 'relieve need, hardship and distress'. Details the Patrons, Presidents and Vice Presidents of the organisation along with the function of the secretary and financial aspects including the funding of the organisation which came from donations from various sources.</p>

	Collection of documents which indicate William Stewart's reminiscences on his time as a member of the Palestine Police Force, all of which are either copies of documents relating to his time in Palestine or collected afterwards. Includes a list of details of Palestine colleagues, a photocopy of a newspaper article published in 1947, a police recruitment video, a later BBC documentary on the Palestine Police Force and a wooden Palestine Police commemorative shield.		
3/1	<u>Byrant's List of Police Colleagues</u> Photocopied list of some of the colleagues of J. D. Byrant from his time as a policeman under the Palestine Mandate from 1947 to 1949. List compiled from a diary and photograph album kept by J. D. Bryant dating between October 1946 and May 1948. Stewart features on the list of those who worked for the Farradiyeh Police Post. 6 other men are listed here and so are potential colleagues of Stewart. Bryant adds a note at the end of the document, highlighting its limitations as the majority of details came from memory and not a record from the time.	1991	5 sheets
